C. Vote relating to accountant's services

MOTION by Ron, to hire Bee Bergwall as our accountant for the 2017 year for the amount of \$4,450. **SECONDED** by Kay, **APPROVED** by all.

III. DIRECTOR'S REPORT – Connie Hillman

- **Gutter/Leak** Eismann started working on the gutter/roof issues Monday, December 19.
- Front door/draft situation: Thus far, the temperature at the front desk has been okay. The staff has not been inundated by gusts of cold wind and the heater behind the desk has been doing a very good job of keeping the area comfortable. Connie has spoken to the staff and several volunteers and apart from one person, everyone seems okay thus far. We have yet to hit the coldest time of the year. Connie's suggestion to the building committee is to purchase an air curtain from Amazon and have our electrician install it. It would be used on the coldest of days. Total cost would probably be about \$350. Connie would like permission to act on this when warranted. MOTION by Polly, to authorize Connie to purchase an air curtain as needed the cost not to exceed \$350. SECONDED by Beth, APPROVED by all.
- System meeting. The system member libraries met with Martina Kominarek regarding the dissolution of the library system. They will be meeting again in February for further discussion. Essentially as all of our present services are covered under other contacts and agreements, the system agreement does little other than offering priority to system member libraries over non-system members. The change would mean that we would be receiving our state aid directly from Harrisburg rather than through the system and be held accountable on our own, rather than aggregately, for state standards. Currently we meet all criteria for state aid.
- Other district information: The circulation polices are currently under review with a revision expected to be approved by the spring. ALA Online training webinars have been purchased by BCFL but will be made available to all libraries free of charge.
- **LEAP into Science:** On December 8, Patricia and Marge attended this workshop created by the Franklin Institute. Our library is one of the pilot libraries selected in southeastern Pennsylvania to host the program. The first of these family science workshops will be held at the end of January.
- We had some wonderful programs in December: a holiday concert featuring the New Hope-Solebury-Lambertville Community Choir and a Santa Story Time with

our very own Neil Gallagher as Santa. Both programs drew a great crowd and lots of very positive comments from patrons.

IV. STRATEGIC PLANNING – Beth Houlton

- A. **MOTION** by Susan, to adopt a resolution, pursuant to Article 4 of the library's Amended and Restated By-laws, to designate a Strategic Planning Committee of the board, chaired by Beth, which will prepare a Strategic Plan to be proposed to the Board during 2017 and meet regularly thereafter to ensure implementation of that approved Strategic Plan. **SECONDED** by Ron, **APPROVED** by all. The committee will have Kay, Carol, Connie, a staff member and one or two others.

- **V. BUILDING/PROPERTY** Connie on behalf of Carol Taylor We have someone coming next week to look into more soundproofing for downstairs. They will give us a proposal to consider. Carol continues to look into various options.

We are close to \$60,000, which is what we raised last year. The updates from Eric have been great and the email reminders to the community are also very good. The development committee has come up with four goals, which will be discussed at the retreat. A conversation ensued regarding etapestry and what we can do to take full advantage of the program.
